E. Regularization/ Contract Status of D/W employees of QHAMC.

The Case was discussed in detail and the members of management committee unanimously agreed that the case may be kept pending Action by HD/DF.)

F. Staff cars of MTI, Nowshera proper allotment..

The Member were briefed that there are 02 vehicles at QHAMC Nowshera, After through discussion the house agreed to transfer one 01 vehicle No.A-1266 (Honda Civic) from hospital to NMC for the use of Dean/CEO and 01 vehicle BRV No A-1274, to Hospital QHAMC for Administrative duties . G. Transfer of Funds from NMC Account to QHAMC Account.

The Case was discussed in detail and the members of management committee unanimously agreed that both the entity have different functions in nature, these the transfer of funds may revised audit observation, however it was decided that that utility bills, Gas and electricity bill 08/2023 be paid from college funds, it is impossible to Transfer funds from one Head to another Head but Gas Bill, Electricity Bill and House officer stipend can be paid from NMC Account till August 2023 and subject to recoupment in due course of time. H. MTI financial and service regulations 2022 implementations .

The Case was discussed in detail and some members of management committee pointed out that there were some reservations of all staff both teaching and Non-teaching regarding qualifications, experience, service structure, leaves etc and the aggrieved staff also submitted reservations in written. On the permission of BoG an anomaly committee was constituted. The committee submitted the recommendations to the chairman BoG as the same was already approved by MC. Furthermore, the BPS scales approved in the said regulations duly approved by MC on the implementation letter of BoG was already implemented as per High court decision/approved regulations for various teaching and Non-Teaching categories.

The MTI scales i-e CPS shall only be implemented prospectively and not retrospectively. The MC approved the above in the best interest of employees. Action by Dean/HD.)
