The selection will be made and the eligibility shall be determined on the basis of MTI, Nowshera Regulations-2022 (www.nmc.edu.pk) and other terms and conditions contained therein.

- 2. The following are not eligible for the above mentioned posts:-
- i. Those who are under active inquiries from Anti-Corruption Department or NAB.
- ii. Those against whom court cases are pending challenging their appointment(s) in NMC and QHAMC.
- iii. Those who are not performing IBP.
- iv. Those who have specifically been barred from holding any executive position(s) from any competent authority.
- v. Those who have been declared inefficient or declared dishonest by any competent forum.
- vi. Those who submit forge documents.
- vii. Those who misbehave during interview or use extraneous pressure.
- 3. In order to render themselves eligible for the above mentioned posts and those who claim not to be barred by the above mentioned conditions shall render an affidavit duly attested by Oath Commissioner, in this respect.
- 4. Eligibility does not render a person suitable for the post unless he / she is competent enough to satisfy the selectors.
- 5. The above mentioned assignments require enthusiastic, professional and hard working individual because of the challenging of responsibilities attached with the post(s).
- 6. Relevant experience against any one of the above mentioned posts, and achievements shall be an added quality.


