Only shortlisted candidates will be called for interview by the House Job Induction Committee of the MTI, Nowshera and induction shall be made in light of House Job Policy approved by BoG MTI, Nowshera in its meeting No. 34<sup>th</sup> whereby it was decided that Graduate of other than public sector shall submit an NOC that their parent institute shall pay their stipend and at the time of appointment shall deposit an amount equivalent to one year house job stipend which shall be paid to the appointees in response to their duties on monthly basis.
